2018 VENDOR / EXHIBITOR REGISTRATION

An additional fee of \$50 is required for each additional representative, spouse, or guest or for purchasing a Banquet ticket. This fee allows the additional individual(s) to attend all Conference Events. If children will be attending, contact the TPA Office at (512) 458-3140 for registration information. The Banquet will be held on Wednesday, June 6th at 6:00 p.m.

As a vendor / exhibitor, you are a vital part of our program and will receive our fullest cooperation. The Embassy Suites Denton Hotel and Convention Center, 3100 Town Center Trail, Denton, Texas 76201, is the site for all general and training sessions, and the site for exhibitor displays. The exhibitor area is on the ground level of the hotel. General registration, breaks, and some other functions will be in the exhibitor area, thus maximizing contact between exhibitors and attendees.
